Rule 18.23.4 (Updated Rule History)

What is commonly referred to as the 'Non-School Sport Participation Rule' was updated at the June 2019 WIAA Executive Board meeting. The rule now clarifies where penalties fall if athletes violate this rule without school permission and what occurs when a school creates these conditions.
